More and more companies are trying to establish net zero ambitions. One type of company are "Greening companies", which are described as those which are serious about lowering their carbon footprint by establishing credible plans to transform their operations and activities in order to become greener. For example, greening companies are concerned with transitioning to electric vehicles.



Greening companies present as part of their corporate responsibility by recording, acting upon and reporting their environmental impact, In general they:

- set an ambition to get to net zero.
- provide a timeline with realistic aims and targets
- present a credible business plan to achieve their targets and
- contribute to a just transition.

DEVELOPING A TRAINING COURSE FOR SMES

BALANCE Project partners are busy writing a training course for the managers and staff of SMEs who are looking to become more sustainable in their actions. The training is based on earlier research undertaken by project partners and the key learning points from the European Green Action Plan for SMEs. It will be based on the European credit system for vocation education (ECVET), in order to support SMEs in transforming their work into greener operations while also improving their financial literacy and enhancing their environmental awareness.
